

North America Wales Foundation Privacy Policy Statement

Your privacy is critically important to us, as such at the North America Wales Foundation we follow a few fundamental principles:

- We never ask you for personal information unless we truly need it.
- We never share your personal information with anyone except to comply with the law or protect our rights.
- We never store personal information on our servers unless required for the ongoing operation of one of our services.
- We aim to make it as simple as possible for you to control what is visible to the public, seen by search engines, kept private, and permanently deleted.

Simply put:

North America Wales Foundation (NAWF) will use your contact information for in-house purposes only and will not share any information about you with third parties. Data from applications made through our website will be used for contact and qualifying purposes, from which you can have your personally identifying information deleted at any time.

Below is our privacy policy which incorporates these goals:

NAWF operates a website under the domain name www.NAWalesFoundation.org and www.nawf.wales. It is the NAWF policy to respect your privacy regarding any information we may collect while operating our website. Website Visitors

Like most website operators, NAWF collects non-personally identifying information that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. The NAWF's purpose in collecting non-personally identifying information is to better understand how NAWF visitors use its website. NAWF does not release non-personally identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

The NAWF also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged-in users and for users leaving comments. NAWF only discloses logged-in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below, except that blog commenter IP addresses are visible and disclosed to the administrators of the blog where the comment was left.

Gathering of Personally Identifying Information

Certain visitors to the NAWF website choose to interact with NAWF in ways that require NAWF to gather personally identifying information such as donations, scholarship applications and contact list. The amount and type of information that NAWF gathers depends on the nature of the interaction. Those who engage in transactions with NAWF are asked to provide additional information, including, as necessary, the personal and financial information required to process those transactions. In each case, NAWF collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with NAWF. The NAWF does not disclose personally identifying information other than as described below. Visitors can always refuse to supply personally identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

NAWF may collect statistics about the behavior of visitors to its website. However, NAWF does not disclose personally identifying information other than as described below.

Protection of Certain Personally Identifying Information

NAWF discloses potentially personally identifying and personally identifying information only to those of its employees and board members that (i) need to know that information to process it on the behalf of NAWF or to provide services available at the NAWF website, and (ii) that have agreed not to disclose it to others. The NAWF will not rent or sell potentially personally identifying and personally identifying information to anyone. Other than to its employees and board members as described above, NAWF discloses potentially personally identifying and personally identifying information only in response to a subpoena, court order or other governmental request, or when NAWF believes in good faith that disclosure is reasonably necessary to protect the property or rights of NAWF, third parties or the public at large. The NAWF takes all measures reasonably necessary to protect against the unauthorized access, use, alteration, or destruction of potentially personally identifying and personally identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. The NAWF website uses cookies to help identify and track visitors, their usage of the website, and their website access preferences. NAWF website visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using the NAWF website, with the drawback that certain features of the NAWF website may not function properly without the aid of cookies.

Children Online Privacy Protection Act (COPPA)

In the unlikely event that NAWF would need to collect personally identifying information for a child under 13 years of age, the guidelines set forth in the [Children Online Privacy Protection Act](#) would be followed, giving parents full control over the content that it might use on its website, media, and promotions.

Dissolution Transfers

If NAWF is dissolved, assets would be dispersed in accordance with the NAWF Bylaws. In such an event, personal information would be deleted and would not be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of the NAWF may not continue to use your personal information as set forth in this policy.

Privacy Policy Revisions

Although most changes are likely to be minor, NAWF may revise its Privacy Policy from time to time, and at the NAWF sole discretion. NAWF encourages visitors to frequently check this page for any changes to its Privacy Policy.
